Compassionate Pricing

20% off all dried cannabis products for patients with disabilities. To qualify you must complete this form and submit it with proof of receipt of financial assistance from a federal or provincial program (see next page).

Low-Income Pricing

20% off all dried cannabis products for patients who earn less than \$30,000 per year or need financial assistance to obtain their medical cannabis. To qualify you must complete this form and submit it with either a) proof of receipt of financial assistance from a federal or provincial program (see next page), or b) a copy of your most recent 'Notice of Assessment' from the Canada Revenue Agency indicating your income falls below \$30,000.
